**LCDC approval sought for the following project contract extensions;**

- Dunhill Community Hall Project 31LDRWAT103347 has submitted its final claim which is currently being prepared for review. While the project has an extension till the 14<sup>th</sup> July '19, a further two months extension is required to facilitate final review and processing of the claim
- Blackwater Distillery 31LDRWAT103411 has submitted their final claim. An architect's report identified two issues to be addressed before final report is prepared and the project is ready for final review. A two month extension is required to facilitate same as their contract expires on the 14<sup>th</sup> July '19
- Comeragh Amenity Area 31LDRWAT103399 have submitted their 4<sup>th</sup> claim for review. An architect's report identified some issues which need addressing before a report is prepared and the project progressed. Their 5<sup>th</sup> and final claim has also been submitted but cannot be prepared until their 4<sup>th</sup> claim is at stage 12 on the Department system. The project will require a two month extension as their current contract expiry is the 14 Aug '19
- Glasha Hydro 31LDRWAT103407 contract expiry is the 14 Aug '19 having had a previous 12 month extension due to a judicial review of the council's planning permission granted. An Bord Pleanála upheld this decision last February, however, a condition within the grant of planning is now the subject of a further judicial review. A new planning application is currently being prepared to include all elements of the project therefore a further extension is required to facilitate same subject to LCDC approval.
