Hi All,

I mentioned after the meeting to some of you about the Brexit Blue Economy Enterprise Scheme which is active at the moment.

It's a €25m fund with €20m still to be allocated & spent before the end of the year.

Funding is available to businesses operating within ten kilometres of the coastline, and involved in blue economy activities including seafood, coastal tourism, boat building and repair, marine leisure and sport, small non-commercial harbour or pier activities, and renewable energy initiatives.

The projects must be completed by the 30th September this year, so a really quick turnaround. It's 50% funding, with up to €200k available, over three types of projects.
